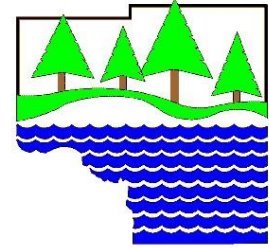

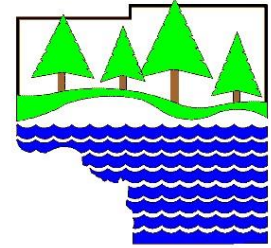

**BACKGROUND:**

Hammerland Construction has been moving forward with the construction of the tailings bridge and the return water line project. Both projects are on track to be completed in the next few months.

Mesabi Metallica Company LLC filed for Chapter 11 bankruptcy on July 8, 2016. On April 26, 2017 the Delaware bankruptcy court selected Chippewa Capital Partners LLC as the best option to salvage the bankrupt Essar Steel Minnesota project in Nashwauk MN. The confirmation hearing has been extended to June 13, 2017 to allow additional time to review the reorganization plan and the DNR's mineral leases. Once confirmed and agreements are made with all of the stakeholders, Chippewa Capital plans to finish constructing the taconite pellet plant within 18 to 24 months and expects to also build an advanced direct-reduced-iron plant in Nashwauk within 33 months.

**BACKGROUND:**

SEH has been providing construction administration and program management services to the ICRRA for the Mesabi Metallica project since 2008. Dave McKenzie has been the main contact with SEH who has provided that service. He has been an integral resource throughout the entire project and his knowledge of railroad operations and processes is invaluable. He retired from SEH in March but agreed to continue working on this project through a temporary employment arrangement with Express Professionals.

Due to many construction and bankruptcy delays, the project has not yet been completed. There is still additional time and effort required to complete the railroad agreements and coordinate the completion of the project. Those agreements will require expertise

The grant agreements that have been funding the expenditures associated with these consultant services expire on June 30, 2017 and will not be extended. ICRRA has been collecting car storage fees from ERP since February of 2015 with revenues from 2015 and 2016 totaling \$413,760.
